



## 20 YEAR LIMITED WARRANTY

Slimline Stone warrants the Slimline Stone Panels to be free from defects in material and workmanship for a period of twenty years from the date of purchase. This warranty is deemed void if product is not used with Laticrete International adhesives and in accordance with Laticrete International Specifications.

Liability under this warranty is LIMITED to the replacement of its product (as purchased) if found to be defective or to refund the purchase price, at Slimline Stone's option. In the event of a claim under this warranty, notice must be given to Slimline Stone, in writing at: 10540 Old Redwood HWY, Windsor CA 95492 ATTN: Slimline Stone Warranty Claim. To obtain remedies under this Warranty, Slimline Stone must receive Consumer's claim before the end of the Warranty Period. All warranty claims must be reported immediately. All products must be inspected prior to installation.
